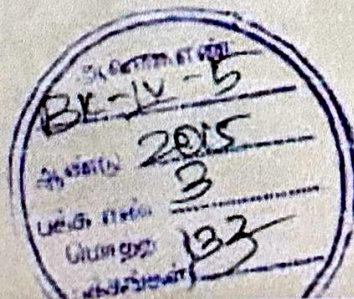
2. Registered office of the Trust :

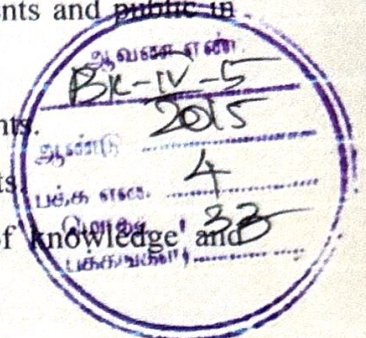

4. Objects of the Trust :

The objects for which the trust has been established are to provide to education, to undertake any other object of socio- economic upliftment of the people and furnishing of any other objectives of general public utility not involving carrying on any activity for profit and for such purposes: purely in service motive only.

- a) to undertake educational activities and for the purpose to construct, run and maintain schools, colleges and educational centers.
- b) to establish Library and Book banks for the benefit of the students and public in general.
- c) to purchase and maintain playground for the purpose of the students.
- d) to construct maintain and run hostels for the benefit of the students.
- e) to conduct educational tours and debates for the expansion of knowledge and betterment of the society.
- f) to publish literature for the betterment of the society.
- g) to grant scholarship, stipends, free studentship, prizes, rewards and allowances, financial and other assistance to the deserving students for the purpose of expanding the object of the trust.
- h) to organise training and employment for youth and women.
- i) to establish and maintain Homes, Orphanages and other establishments for relief of and to give help to the poor and destitute, orphans and widows and other wise provide for them.
- j) to establish, maintain and run institution for senior citizens, their care, treatment, day home etc., and to grant assistance in cash or kind for the purpose.
- k) to collect and receive Donations, Contributions, Subscription, bequest, grant-in-aid, other aid, assistance in cash or kind from all persons and institution interested in the object of the Trust.
- l) to take, accept donations, loans, subsidies, aids, assistances (both monetary and in kind) from whatever sources available.
- m) To carry and run institution having objectives similar to the trust not involving carrying on any activity for profit.
- n) To do all acts and activities which are conducive and incidental for carrying out objects as referred to herein above.

5. Beneficiaries :

All the mankind without any discrimination on the basis of religion, caste, colour, creed or sex shall be beneficiaries of the trust.

The trust shall exist solely for philanthropic purpose and not for the purpose of profit.

The object and the activities of the trust shall be limited to India only.

6. Trust Fund :

The author of the trust declares that the sum of Rs.1000/- (Rupees One thousand) only that has been dedicated by him for public charitable and educational purposes and objects of general public utility described above, the receipts of which the trustees have acknowledge and that the trustees shall and will stand possessed of the said sum of Rs.1000/- (Rupees one thousand only) upon trust and also any other properties movable or immovable which the trustees may from time to time receive for augmenting the Trust fund or for specified purposes connected with the objects of the Trust arising from donation, bequests, gifts, legacies or grants in cash or kind or from any other source whatsoever and also of any investments from the time being representing the same (hereinafter called the trust fund) and also of the net income from the Trust fund into trust, and apply both the income and the capital of the Trust Fund for the purposes of the Trust.

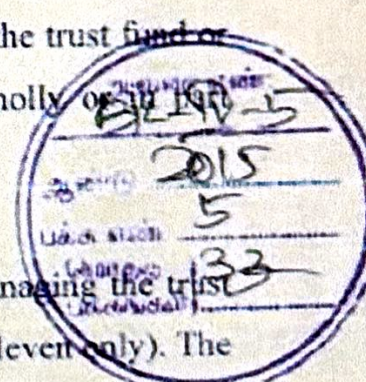
The trust fund shall be held in the name of the trust and not in the name of the trustees.

If the objects for which the trust has been created shall fail, or cannot be satisfactorily fulfilled for any reason, the board of trustees shall be at liberty to apply the trust fund or any portion thereof to any other trust or institution having objects wholly or similar to this Trust.

7. Board of Trustees:

The general management and control of the trust for the purpose of managing the trust affairs and properties shall vest in a board of trustees not exceeding 11 (Eleven only). The board of trustees of trust shall comprises of all the 12 trustee nominated by the author of the trust including himself. The author of the trust has himself nominated the following persons as office bearers with designations as under and the term of office is five years.

The trust board shall not be irregular or invalid or illegal on account of there being no complete number of 11 trustees to function at any time. The minimum members of trustees to function shall be 9 (Nine) at any time.

Any trustees may resign by giving notice in writing to the chairman or the Vice Chairman of the trust.

A trustee shall cease to be a trustee on the happening of the following events.

- i) If he resigns.
- ii) If he becomes in sane or of un-sound mind.
- iii) If he is adjudged as insolvent.

In the event of any of the first or subsequent trustees ceasing to be a trustee of reasons of death, resignation or any other reason as herein, any person nominated by the members of the said trust shall automatically become trustee in place of the above mentioned one.

That the trustee acting against the interest of the trust may be terminated from the trusteeship by 3/4TH majority of the trustees by giving him a request of this intention to the trustee concerned.

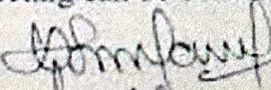
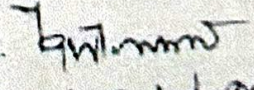
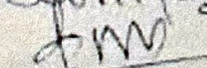
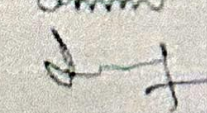
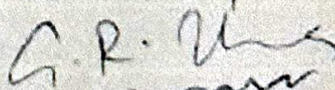
The office bearers so nominated by the Author amongst the First trustees will hold office for a period of five years and thereafter, there will be an election and the retiring office bearers may also be eligible to be elected as office bearers of the same post previously held again.

The decision taken by 2/3 and members of the trustees at any meeting of the board of trustee shall be decision of the board of trustees and shall be given effect to unless inconsistent with the object of the trust.

That the trustees shall meet every month for the purpose of the trust and taking decision for the management of the trust and its fund.

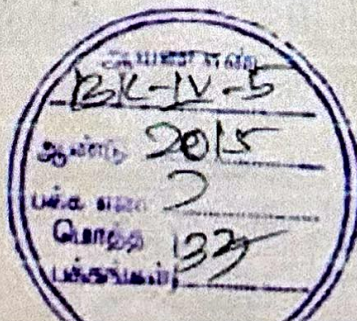
That the personal presence of five trustee will be quorum for a meeting.

a) The trustees may invest the Trust Fund either in the purchase of immovable properties or of mortgage immovable properties or in such manner as allowed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investments from time to time, provided such investments shall not be made which are directly or indirectly for the benefit of any person referred to in such section (3) of section 13 of the Income tax act, 1961 or any subsequent amendments as may be made from time to time. Investments of Funds of the trust shall be made in accordance with provision of section 13(1)(d) read with section 11(5) of the income tax act-1961.

b) If the income from the trust property in a particular year is not fully utilized, the unexpended income subject to the applicable provisions of section 11(2) of the Income tax act, 1961 shall be carried over to the next year or years and spent in such subsequent year or years of the advancement of any of the object of the trust.

c) Application of income for religious purposes, if any, will be restricted to the limits prescribed under the income tax act as amended from time to time.

1). Chairman :

The chairman of the trust will be the virtual head of the trustee and who is also managing trustees of the Trust. The chairman shall preside over all the meeting of the trust.

2). Vice- Chairman :

The vice-chairman of the trust shall act in the absence of the chairman and in his absence all meeting are to be presided by the vice chairman. In case of the absence of the Chairman and Vice Chairman also, the trustees are empowered to elect any one out of them to preside over the meeting.

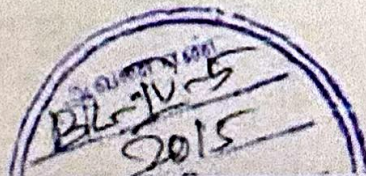
3). Managing Trustee :

The chairman of the trust is also the managing trustee of the trust. He shall manage of the affairs of the trust and to look after day to day business. All records of the trust shall remain in the custody of the managing trustee. He is entitled to call for the meeting.

That the managing trustee shall prepare the annual report of the trust and place the same before the board of trustees.

4). Secretary :

The secretary will be the chief executive of the Trust and shall do all the acts and deeds which may be necessary and expedient to achieve the objects of the trust but in consultation with the chairman. However, the decisions taken by the secretary are to be ratified in the immediate next meeting of the Board of Trustees. He shall maintain all the records of the trust at the registered office of the trust. He shall call the meeting of the Board of trustees in consultation with chairman. He shall record the minutes of all the meeting and will implement resolutions thereof. He shall prepare the annual report and shall do all other acts as may be assigned to him by the chairman. He shall always keep informed the chairman of the Activities of the Trust.

5). Joint Secretary / Secretaries :

The joint secretaries shall do such acts as may be assigned by the secretary. They shall be accountable to and shall act in consultation with the Chairman / Secretary.

6). Treasurer :

The Treasurer shall be responsible for maintaining regular and proper accounts of all receipts, payments, assets and liabilities of the Trust. He shall get accounts audited within four months of the close of the financial year and place them before the Board of Trustees. He shall prepare budget estimates for the ensuing year and get them approved by the Board of Trustees. He shall do all other acts, as may be assigned to him by the chairman.

10. Powers or functions of the Board of Trustees :

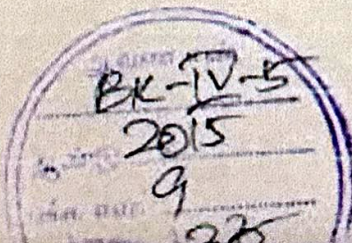
For the furtherance of the objects of the Trust, the Board of Trustees shall have the following powers:

- (i) to accept and receive any donation, contribution, bequest, grant-in-aid or assistance, subscription in cash or in kind including any property from any person, body of persons, company, corporation, charitable institutions, funds, trusts, etc. on such terms and conditions as the Trustees may think fit:

- (ii) to apply the whole or part of the income of the Trust Fund or accumulation thereon or whole or part of the corpus of the Trust Fund for the purpose of carrying out the objects of the Trust and other activities which are incidental and necessary to any one or more of the objects of the Trust as the Board of Trustees may decide from time to time;
- (iii) to invest surplus funds not needed for immediate use in deposits of Nationalized or Scheduled banks or government securities or as prescribed by the Income Tax Act from time to time.
- (iv) to borrow money for the purpose of the Trust and to mortgage or charge its properties for the same;
- (v) To sell, alter, vary, transpose, dispose off, alienate or otherwise deal with any property, movable or immovable, comprising the Trust Fund or any investment representing the same and to reinvest the same in any manner as the Board of Trustees may think fit.
- (vi) To let out or demise any immovable property comprised in the Trust Fund for such period and at such rent, on such terms and conditions as the Board of Trustees in their absolute discretion may think fit;
- (vii) To open account with any nationalized/scheduled bank or banks in the name of the Trust; to operate such account and to give instructions to the bank that such account may be operated upon by the Treasurer of the Trust and in his absence any one nominated by the Board of Trustee.
- (viii) To adjust, settle, compromise, compound, refer to arbitration all actions, suits, claims, demands and proceedings regarding the Trust properties;
- (ix) to appoint, constitute attorneys or agents and to delegate to such attorney or agents all or any of the powers vested in them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place;
- (x) to appoint legal advisors and such other Professionals on such terms and conditions as the founder of the trustee deem fit, from time to time;

- (xi) to make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and of running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust or holding meetings and elections of the office bearers;
- (xii) to set apart the whole or part of the income or the corpus of the Trust Fund for any of the objects of the Trust;
- (xiii) to accumulate the income of the Trust and apply the accumulated income for one or more of the objects of the Trust;
- (xiv) to pay all charges, impositions and other outgoings payable in respect of the Trust Fund or any property comprised in the Trust and also to pay all costs incidental to the administration and management of the Trust Fund for the time being;
- (xv) to appoint and/or dismiss office staff and other employees, to look after and manage the properties constituting the Trust Fund and to allot to such persons such duties as the Board of Trustees may think fit and proper;
- (xvi) to give contributions to other Trusts and institutions with similar objects and whose income is exempt under the provisions of the Income Tax Act, 1961;
- (xvii) to join, co-operate, amalgamate with Trust or Fund having similar or allied objects upon such terms and conditions as the Board of Trustees may in their discretion think fit;
- (xviii) to appoint committees/sub-committees for management and operation of various projects/activities to be undertaken from time to time or for selecting the competent persons for carrying on the research;

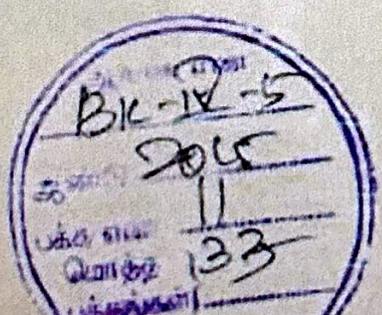

11. Bank Accounts :

The Board of Trustees may from time to time open and maintain Savings account, Current account, Loan account in the name of the Trust, Bank account or accounts with Nationalized or schedules Banks and same shall be operated under the signature of Treasurer of the Trust. 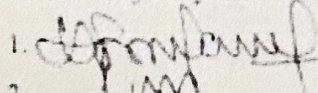
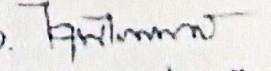
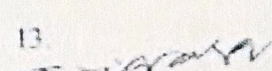
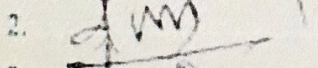
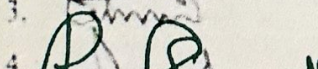
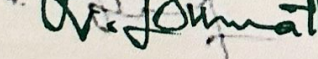
The financial year shall end on 31st day of March each year. The accounts shall be got audited by a Chartered Accountant to be appointed by the Board of Trustees. The audited accounts and the report of the auditors shall be placed before the Board of Trustees in its meeting to be held before September each year.

Notwithstanding anything contained in the foregoing clauses, it is hereby agreed and declared unequivocally that this deed does not contain any provision for the transfer or application at any time of the whole or any part of the income or assets of the Trust Fund for any purpose other than the purposes mentioned hereinabove.

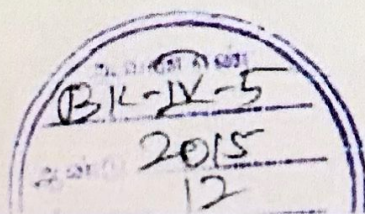
13. Amendment to the Trust Deed :

It is declared and understood that the trustee shall have powers to frame rule and or by-laws, alter, vary, amend, delete and also add rules and or by-laws for the conduct and management of the trust or to the trust fund or for carrying out the objects of the trust and such rules and by-laws framed, amended, altered, varied, deleted or substituted shall have the same force as if they have been incorporated in the original trust hereby created but not repugnant to the object of the trust.

If required, the board of trustees in their meeting called for this purpose with at least 15 days notice, may adopt resolutions for the amendments in the deed of Trust with Two-Third majority of the total numbers of Trustee.

No amendment in the deed of the trust shall be made so as to alter the basic character or the object of the trust and no such amendment which may prove to be repugnant of the provision of the section 2(11) 11, 12, 13 and 80-G of the Income Tax Act 1961. No amendment to any specific clauses of deed of trust shall be made without prior approval of Chief Commissioner/Commissioner of Income/Director of Exemption as the case may.

14. Liability of Trustee or Trustees :

Subject to the powers and responsibilities of the trustees set out in this deed, no trustees shall be liable for any loss to the trust properties arising by reason of improper investment made in good faith or for the negligence or fraud of any agent employed by him/her or (by way other trustees thereof) although the employment of such agent shall not strictly be necessary or expedient or by reason or any mistake or omission made in good faith by the trustees or by reason of any other matter or thing except willful or deliberate fraud on the part of the trustees who alone may be, subject to be made, so liable.

15. Settlement of Disputes :

Internal disputes, if any, arising out of the interpretation of any of the clauses of the deed or relating to any of the affairs of the trust shall be referred to and settled only by arbitration as provided under the Indian Arbitration and Conciliation Act, 1996 or any statutory reenactment thereof. It shall not be competent for any trustee to take any matter to a court of law for relief without first referring the same to Arbitration as aforesaid.

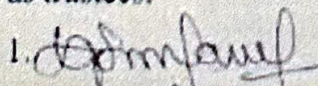
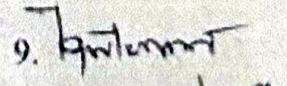
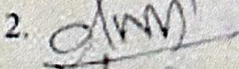
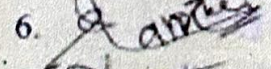
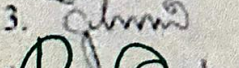
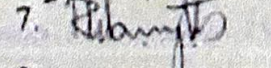
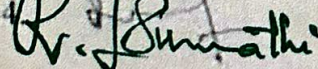
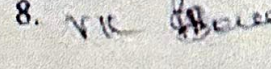
16. Duration of the Deed :

The Trust is irrevocable and will continue in perpetuity.

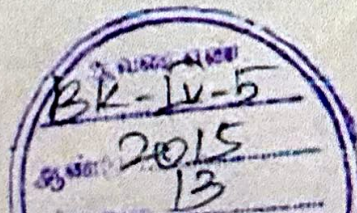
17. Immunity of Trustee :

18. Power to Sue :

The managing trustee may sue and be sued in the name of the trust.

19. Constitution of Board of Trustees :

The Board shall be constituted by the 13 (Thirteen) founder trustees named in this deed.

- i) The founder trustees shall hold office till their life time.

- iv) If the founder trustee resigns and nominates his legal heir then the mutual consent of other trustees is not necessary.

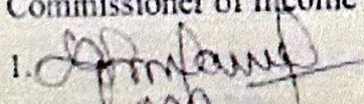
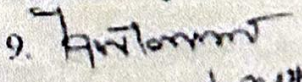
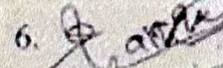
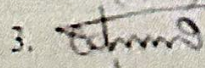
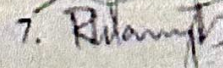
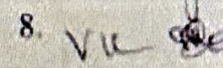
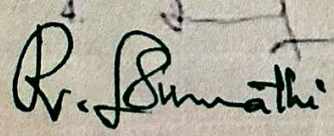
20. Saving Clause :

The net funds and other assets, if any, after meeting all liabilities will be handed over to any other similar trust or institution similarly satisfying requirements of the Income Tax Act 1961 as may be decided by the last trustees subject further condition that it shall be so given to an institution as approved by the Chief Commissioner / Commissioner of Income or Director of Exemption as the case may be.
